



NEW ONE-CALL OPERATOR TO REQUIRE NEW INTERNET ONE-CALL PROCESS

UTCA Schedules Training Seminars

On February 17, 2010, One Call Concepts (OCC) will become the new vendor operating the State's One-Call Center. As noted in a previous UTCA Construction Advisory, the current Fax-A-Locate process will continue, and excavators will only be required to sign a new Fax-A-Locate agreement with One Call Concepts. Of **significant importance** to excavators is that the **current remote internet ticket submission process will change!**

IBIS and ONTRY will be replaced with a new web-based product called ITIC. Because ITIC is web-based, users will only need a browser (preferably Internet Explorer) and a free Java download. No specialized programs will have to be installed on a user's PC.

UTCA with OCC will conduct training sessions for contractor/excavator staff who wish to be educated in the new ITIC web-based internet excavation notification process in lieu of calling the 1-Call Center. This service was previously only available to larger construction companies but is now available for all firms that wish to use this more efficient communication process.
