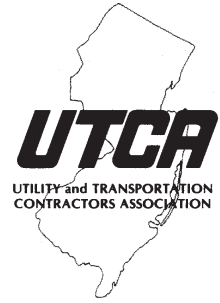


# ***We Are Pleased To Announce Our Upcoming 2012 Executive Seminar At The Marriott St. Kitts Resort***
